Lincolnshire Alert (locally known as LincsAlert) is a messaging system within the Lincolnshire Police Boundary.

Business Watch enables us to give information to registered members on business crime and community safety. Members are also easily able to provide information to the police.

If you would like to register your business, visit our website at www.lincsalert.co.uk and choose the BUSINESS PORTAL. Just click the 'register now' button.



Benefits of the system include:

- Website available 24 hours a day
- Totally confidential, secure service
- Subscribe to receive alerts by email, phone and text
- Report information to your Neighbourhood Policing Teams
- Receive feedback and updates about your reports
- Completely free to receive service
- Unsubscribe at any time

What happens when I register my business?

When a business is registered, we ask one member of staff for that business to act as the account holder, this will be the person who can update details on the account if required.

After you have registered your company details, we may send you a confirmation email to verify we have your correct details. Within this email will be a verification link that you MUST click on to finalise your registration. Once this is completed, you will start to receive alerts.

You are fully in control of your account and can adjust the level and types of alerts you receive by logging in to your admin account and updating the message settings option.

If you want to report suspicious activity or matters that concern you, you can do this quite simply by going to 'report information' on your admin account and follow the simple steps. We receive this information automatically and the appropriate department will decide what to do with the information supplied. Sometimes we may just add it to our intelligence system, but you will be advised what course of action we are taking.

**You should NOT use the facility for reporting actual crime taking place.
